Notice is hereby given that by an order dated February 17, 2021, the Mumbai Bench (Court - IV) of the National Company Law Tribunal ("NCLT" or "Tribunal"), a copy of which is enclosed as **Annexure - 1** to this notice, has directed to serve notice to the creditors of GMR Highways Limited ("**Company**") for the purpose of considering, and if thought fit, approving with or without modification, the Scheme of Amalgamation ("**Scheme**"), as approved by the Board of directors and consented by all the members of the Company, concerning amalgamation of the subsidiaries of the Company, namely GMR Tuni-Anakapalli Expressways Limited ("**Transferor Company-1**") and GMR Tambaram Tindivanam Expressways Limited ("**Transferor Company-2**") along with their respective shareholders and creditors with the Company.
