Notice is hereby given that by an order dated February 17, 2021, the Mumbai Bench (Court - IV) of the National Company Law Tribunal ("NCLT" or "Tribunal"), a copy of which is enclosed as **Annexure -1** to this notice, has directed to serve notice to the creditors of GMR Highways Limited ("Company") for the purpose of considering, and if thought fit, approving with or without modification, the Scheme of Amalgamation ("**Scheme**"), as approved by the Board of directors and consented by all the members of the Company, concerning amalgamation of the subsidiaries of the Company, namely GMR Tuni-Anakapalli Expressways Limited ("**Transferor Company-1**") and GMR Tambaram Tindivanam Expressways Limited ("**Transferor Company-2**") along with their respective shareholders and creditors with the Company.
